SECTION 2: REQUIREMENTS:

- 1. The Official Zoning Map shall not be amended until the Conditional Use and required documents have been approved by the County and filed at the Office of the Register of Deeds. The filing of the Conditional Use and required documents shall be within a one (1) year period from the date of approval of the Zoning classification by the Governing Body. If the Conditional Use is not filed within the one (1) year period from date of approval, based upon failure of the applicant to meet all requirements, the Zoning classification shall remain as the prior designation and classification. On or before October 15, 2014.
- 2. Notification to Planning Office of any development with proper permits obtained.
- 3. Comply with State and County Environmental, Zoning and Subdivision Regulations and Article IV Commercial Solar or Wind Energy Project Regulations.
- As provided by K.S.A. 12-760, within 30 days any person aggrieved thereby may maintain an action in District Court to determine the reasonableness of this decision (November 15, 2013).

SECTION 3: THEREFORE, this Resolution shall take effect upon publication one (1) time in the Official County Newspaper.
